Installation Instructions for Part No. 13200

HARDWARE INCLUDED:

Qty	Description
6	15" Grips
1	75 pk of Truss Head SS screws

TOOLS REQUIRED:

- Power Screwdriver (T20 Torx Included)
- Tape Measure
- Pencil or Marker

READ ALL INSTRUCTIONS CAREFULLY PRIOR TO ASSEMBLY

Step 1: Find the center the traction area on the trailer deck. Mark this on the trailer deck at the rear of the trailer.

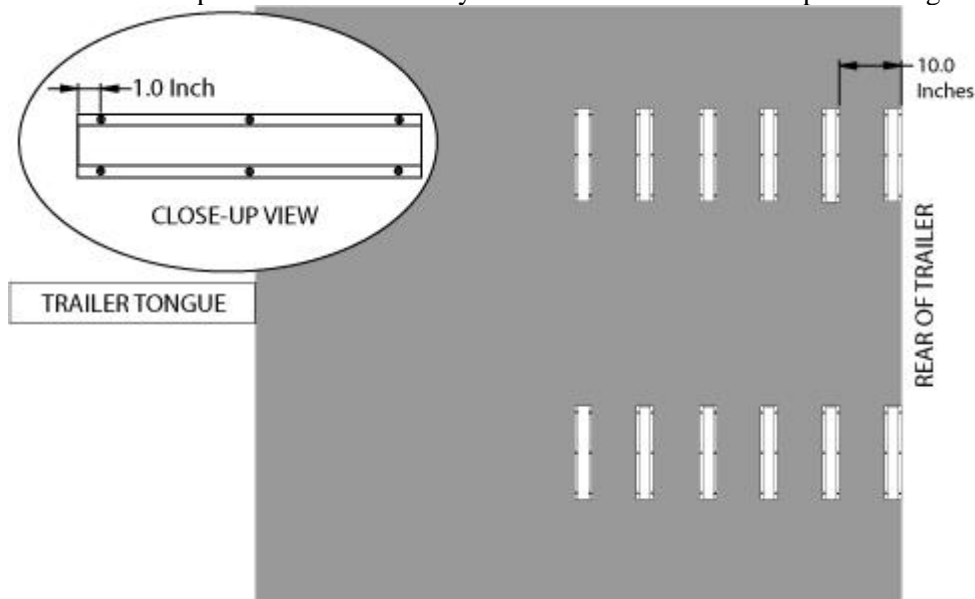
Step 2: Place the first Grip at the very rear of the trailer deck centered on the mark from **Step 1**.

Step 3: Layout the remaining 5 Grips on the deck, making sure the Grips are 10 inches apart from center to center.

CAUTION: Before installing screws, check for adequate clearance where marker lights and wires have been installed under the trailer deck.

Step 4: Use a power screwdriver to fasten the Grip to the deck using 6 screws per Grip. Place the corner screws 1" from the edge of the Grip, and center the 2 middle screws. **NOTE:** The screwdriver should be powerful enough to drive the screws through the Grip and into a wood deck without pre-drilled holes.

WARNING: CALIBER Grips are designed to add traction to the trailer deck for the snowmobile track, but are slippery, especially when wet or covered with frost, ice and/or snow. Extreme caution should be taken when walking or climbing on any trailer deck on which Grips are installed. Always load snowmobiles at low speeds using extreme caution.
