## Installation Instructions for Part No. 13204

### HARDWARE INCLUDED:

6	15" Ramp Grips
1	#10 x 1" Stainless Steel Truss Head Screws 33 pc Pack
1	T-20 Torx bit

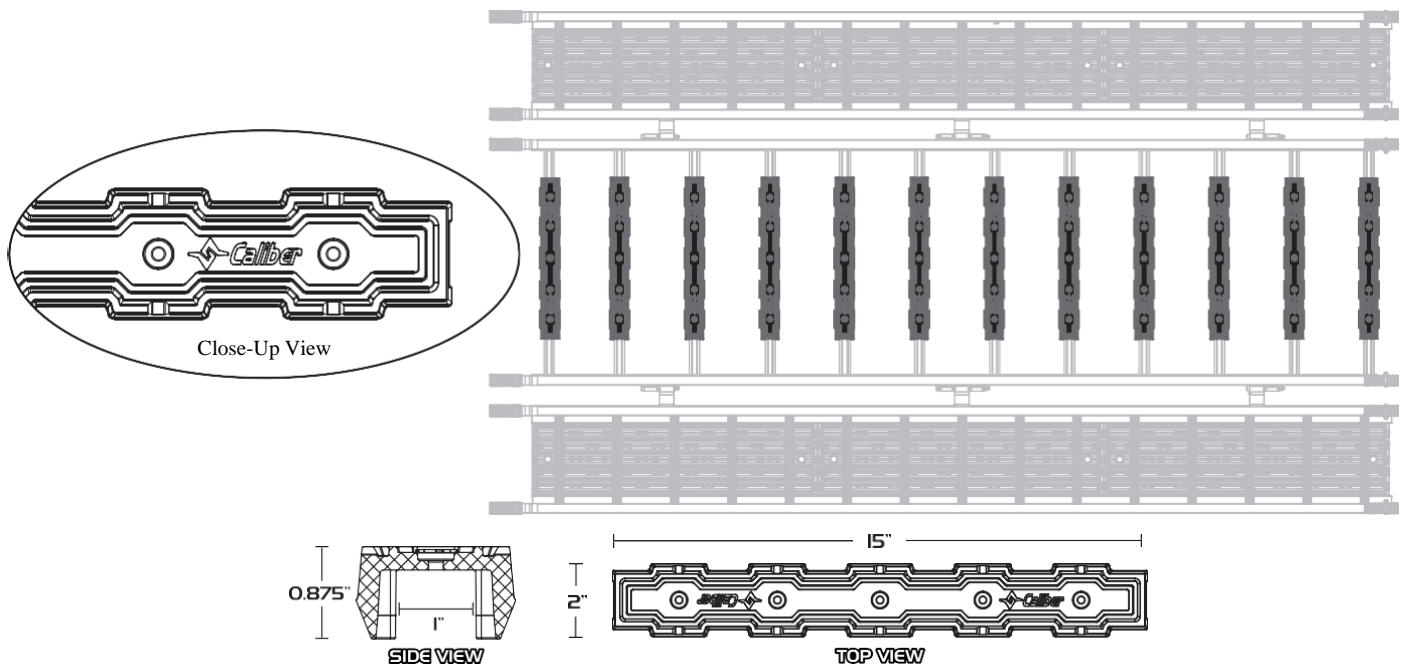
### TOOLS REQUIRED:

- Power Drill
- Tape Measure
- Pencil or Marker
- 9/64th drill bit

### READ ALL INSTRUCTIONS CAREFULLY PRIOR TO ASSEMBLY

- Step 1:** Find the center of the traction area on the trailer ramp. Mark this on the trailer ramp at the rear.
- Step 2:** Place the first Ramp Grip at the very rear of the trailer ramp centered on the mark from **Step 1**.
- Step 3:** Layout the remaining 5 Ramp Grips on the ramp.
- Step 4:** Pre-drill pilot holes at 9/64th into aluminum cross member through ramp grip in all holes
- Step 5:** With Torx driver carefully tighten to aluminum cross rail. (Do not overtighten or you will strip out aluminum)

**WARNING:** CALIBER Ramp Grips are designed to add traction to the trailer ramp for the snowmobile track, but are slippery, especially when wet or covered with frost, ice and/or snow. Extreme caution should be taken when walking or climbing on any trailer ramp on which Ramp Grips are installed. Always load snowmobiles at low speeds using extreme caution.
